The Education Committee has voted all of our major priorities out of committee including: starting salaries, COVID pension credit, \$500 income tax credit, due process, teacher exit surveys, play based learning, the end of EdTPA, etc. It is time to stay vigilant. The lobby day (April 26) will be crucial. We may need another push later in the session. The session ends June 7. *Grass roots advocacy is essential.* TRB Bill: Sean Scanlon (CT Comptroller) seems to be in favor of the Teacher Retirement Board changes which is of concern to our Retired as the retired person must be under the TRB insurance and that only retired members could vote on it. The public hearing occurred but it hasn't been moved out of committee yet. A request for talking points for the remaining county forums occurred. Urban Intern appointment: Kate Tobin has been appointed.
